## **Announcements**

- Marmot staffing changes
  - Mark and Jordan have left Marmot. Replacement hiring process is on hold until the new executive director starts.
- LoC sample non-ISBD records
  - We have had time to take a look at these sample records, and \*Action Item: Lloyd will delete them.
- Deleting 938s
  - Lloyd is still working on deleting the 938 fields. These were vendor data that was cluttering up our records. Most of them have been deleted already, but there are a few that appear to be something from CMC, so they may have local value. \*Action Item: Lloyd will check with CMC about them.
  - The load profiles have been changed to not load the 938s. So you don't have to continue to delete them from OCLC. However, if anyone does need these to load, we can change them back.

## **Reports**

- Duplicate Committee Report
  - Duplicate committee continues to work with Brandon on the new duplicate checking utility with Tableau. The most current version can be accessed on dev.marmot.org. Contact User Services for the login. Brandon tried to add a location limiter, however the current behavior is that it won't see a duplicate unless you have selected both libraries that have one of the records. That way you would have to select all libraries to see all of your duplicates, but then you would see everyone's duplicates. We are continuing to refine this.

# • Reindexing Report

• The committee did not meet this month because we were waiting to formal the arraignment with III. The agreement is now finalized, and we expect to have the III data analyst join our reindexing meeting in June and move ahead with the indexing project in June.

## **Discussion Topics**

- IUG report Instead of a mini-IUG this year Brandon and Lloyd will report what we learned to each of our committees.
  - o B&T implements acquisitions API in August
    - Many book and media vendors were present in the vendor room. Lloyd found out that Baker & Taylor is planning to implement III's acquisitions API in August. Gobi (formerly YBP) has been a beta tester for a while, but none of our members use Gobi as a major supplier. However, several of our members use B&T, so we could try to implement the new system this year if any members want to try.
    - Jamie says that CMU has been considering starting to purchase from an academic book vendor, like Gobi, instead of Amazon, and they might be interested in trying this out with them
    - We don't know how this new process would affect our duplicates problem. We will have to experiment with how to make it work best.
    - Will the API create a duplicate with every order? Can it attach orders to existing records? Based on what match point? Do order records need 020 fields? These are questions to figure out when setting API acquisitions. We want to avoid setting up a system that will really be more work because it creates duplicates.

### o III Context Engine

This is what III is calling their new product. They claim it will be a revolutionary implementation of linked data. We'll see. It sounds like they hope that it will eventually replace Encore, Sierra and Polaris. III seems to be devoting a lot of resources toward it.

# Regex in field protection

- In the load profile forum users talked about how they discovered that load profiles can protect fields, or not, based on the content of the target field. For example, maybe we could protect our 590 fields if and only if they had the code 'MLN' in the field.
- It seems that this is not a feature that III intended to build into the system or was even aware of. It could be very powerful, however as an unsupported feature its continued functioning from version to version is not guaranteed.

#### OpenRefine

- Lloyd presented at IUG about a few topics. Some of them Marmot people are already aware of. However, the part about using OpenRefine may be new to some of you. He reprises that part of the presentation quickly for this group. The whole Powerpoint will be posted on the UCC page.

## Record numbers in bib records. 908 .o, 909 .c

- Lloyd realized that we have record numbers for attached records in our bib records. There are order record numbers in 908 fields and a few checkin record numbers in 909 fields.
- This is poor practice because the attached records can move to different bibs or even be deleted, but the MARC fields are static.
- When we export records the export profile populates these same fields with the numbers from the currently attached records. If numbers live in the bib records those would be exported as well. The numbers in the export would be duplicated or worse, the exported numbers could be obsolete because those records aren't actually attached to this bib any longer.
- For this reason Lloyd would like to delete these fields from the bib records and change the loaders to
  exclude these fields from loading in the future. If anyone is actually using these data please contact
  Lloyd.
- Nobody at the meeting reports needing these numbers in the bib records.

o Jamie suggests that Lloyd should investigate where these numbers are coming from before we delete them. \*Action Item: Lloyd figure out whose record numbers are in the 908s and 909s.

# Create Lists files reorg

- We started doing a nightly export of records for CMU. This is using review file number 1 in Create Lists. This was our largest review file (besides the one for the Pika export).
- o The nightly process will over write whatever is in file 1 and rename it CMU Export Do not use.
- o CMU does not use the file during the day, so people could actually use it, but they need to be aware that it will be cleared every night.
- o Lloyd moved files around so review file 1 is only as large as it needs to be for CMU's export. File 3 is now our largest available list at 724,516 records.
- o Also, the 400,000 and 500,000 record lists have been eliminated because Lloyd realized that you can't do a global update on more than 300,000 records at a time, so they were not actually very useful.
- o There is now an additional 200,000 record list instead.
- o If you do need an additional very large file, contact Lloyd and we can move files around to make it possible.
- Please take care not to use these very large lists for small files that could fit in our much more numerous smaller lists.
- We are anticipating that Sierra 4.0 will allow us to use APIs for record exporting. Theoretically this will mean we don't need any review files for the Pika or CMU bib record exports. This would free up 2.8 million records that we could spread around our review files. If that pans out we can look at a complete reorganization of our review files again.

#### • Sierra 4.0

- o There is a problem with Prospector that prevents us from upgrading at this point. It will not display item status correctly in the Encore version if we upgrade to Sierra 4.0. It would only display the status code instead of the label. That is very unhelpful for Prospector users who would not be able to see if items are checked out or available unless they knew the meaning of our internal codes. This problem should be fixed when Prospector upgrades to the newer version of Inn-Reach later this summer.

- o Lloyd used the notes we've been creating in 995 fields to find these load profiles that are no longer seem to be getting used, and he would like to have III delete them unless they are actually being used.
- o Jamie says that m2btab.msgovn is one they use regularly so we should keep that one.
- o That means that Lloyd's process to check use of these may have been in error. He will double check them all before having III delete any of them.
- Jamie points out that they can be saved as text files and easily recreated, so deleting them is not actually that big a deal.
- We will wait until after next month's UCC meeting before deleting any. Contact Lloyd if you need one of them kept.

We think it is mostly due to bad records from Overdrive and Hoopla, but there could also be problems with Sierra records. We can't change the bad records from vendors, but we can look into how we might change Pika to work anyway. \*Action Item: Set up meeting with duplicates committee and R&D (when they have time) to look at improving automatic grouping.
